**ORDINANCE 2019/2020 - 5**

**AN ORDINANCE PROHIBITING SMOKING  
ON LIBRARY PROPERTY**

WHEREAS, the Board of Library Trustees (the Board) has control of the supervision and care of Library District facilities and grounds (75 ILCS 16/30-55.15); and

WHEREAS, the Board has determined that smoking and/or use of any tobacco or cannabis products on Library District property should not be allowed.

NOW, THEREFORE, BE IT ORDAINED by the Board as follows:

**Section 1. Prohibition.** Use of tobacco and cannabis products or tobacco and cannabis related products are prohibited on Library District property. This prohibition applies to all facilities, all grounds and all vehicles. This prohibition applies to smoking, smoking products, smokeless tobacco, other forms of tobacco and cannabis products, and e-cigarettes.

**Section 2. Violations.** Violations of this Ordinance shall result in suspension of Library privileges for a period not to exceed twelve months per the “Procedures for Issuing and Retaining Patron Misconduct Warnings.”

**Section 3. Signs.** Signs may be posted on Library District property to provide notice of said prohibition.

**Section 4. Miscellaneous.** This Ordinance shall be in full force and effect from and after its passage. Any Resolutions or Ordinances in conflict herewith are hereby repealed. If any part of this Ordinance is adjudged invalid, such adjudication shall affect only that part of this Ordinance specifically covered thereby and shall not affect any other provisions or parts of this Ordinance but shall be severable therefrom.


