ORDINANCE 2020/2021-2; BUDGET AND APPROPRIATION

ANNUAL BUDGET AND APPROPRIATION ORDINANCE FISCAL YEAR JULY 1, 2020 - JUNE 30, 2021

This Ordinance constitutes the Budget and Appropriation Ordinance for the St. Charles Public Library District, Kane and DuPage Counties, Illinois, for the fiscal year beginning July 1, 2020 and ending June 30, 2021.

BE IT ORDAINED by the Board of Library Trustees of the St. Charles Public Library District as follows:

SECTION 1. The following budget and appropriation amounts are adopted for the fiscal year beginning July 1, 2020 and ending June 30, 2021.

SECTION 2. As part of the annual budget, it is stated:

- a. The cash on hand at the beginning of the fiscal year is \$16,780,160.4
- b. The estimated cash expected to be received/appropriated during the fiscal year from all sources is \$8,352,751.
- c. The estimated expenditures for the fiscal year are \$24,129,102.
- d. The estimated cash expected to be on hand at the end of the fiscal year is \$1,003,809.
- e. The estimated amount of taxes to be received by St. Charles Public Library District during the fiscal year is \$8,019,587.
- f. The estimated amount of income to be received from sources other than library taxes for the fiscal year is \$333,164.

Notes

¹In 2019, the Library District issued Debt Certificates for \$4,835,000. Proceeds from the sale of the Debt Certificates will help pay for the cost of substantial capital improvements. The Debt Certificates will be paid off in annual installments with the final installment payment made in the year 2030. Installment payments to retire the Debt Certificates are made from the Corporate Fund/General Fund.

² Included in this Ordinance are items for "Facilities Improvement" as part of the Library District's Renovation Project – see footnote 3.

³The Library District is in the process of making substantial capital improvements (Renovation Project). The Renovation Project extended beyond the FY 2019-2020. Timing of the work on the Renovation Project depends on a variety of factors common to construction activities. The primary sources of funding for the Renovation Project are the Library District's Special Reserve Fund and the proceeds from the 2019 sale of Debt Certificates.

⁴Represents audited balances, not including real estate tax revenues received in 2020 from the Levy Ordinance filed in 2019.

SECTION 3. Funds in the total amount of \$46,869,000 or so much thereof as may be authorized by law, be and the same are hereby appropriated as specified.

SECTION 4. All unexpended balances of proceeds received annually from public library taxes not in excess of statutory limits may be transferred to the Special Reserve Fund.
