Hello.

My name is Kathleen Van Dyke and I have two young children who have been continuously threatened and discriminated against at the St. Charles Public Library for having a medical exemption to face coverings. We have been polite, calm, yet firm, that our medical exemption should allow us equal access to the public library. Each time, Edith has threatened us with police force as well as the fear of being banned from the library indefinitely. We are looking to hear from the board tonight, Jan 22. Is this what you stand for? Homeschooling families being denied equal access to the (necessary) tangible experience of browsing and selecting literature for educational and enjoyment purposes? Do the board members of our library genuinely believe stealing a child's love for reading and socializations with literature are in any way okay for the future generations? As if enough hasn't been taken from these innocent children already, please help us understand the theft you are enforcing on these children.

In the meantime, I have included a letter that confirms our family's legal rights to claim our medical exemption in a public place during operating hours. Please read this through for the board members and the viewing public attending this virtual meeting. Thank you for your time.

NOTICE OF NON-COMPLIANCE AND DISCRIMINATION

Re: NON-COMPLIANCE WITH COVID-19 REGULATIONS FROM THE ILLINOIS DEPARTMENT OF PUBLIC HEALTH (77 III. Admin. Code 690.50); and THE AMERICANS WITH DISABILITIES ACT OF 1990 (Title 42, 126 U.S. CODE): and NONDISCRIMINATION ON THE BASIS OF DISABILITY IN STATE AND LOCAL GOVERNMENT SERVICES (28 CFR Part 35); and NONDISCRIMINATION ON THE BASIS OF DISABILITY BY PUBLIC ACCOMMODATIONS AND IN COMMERCIAL FACILITIES (28 CFR Part 36): and DEPRIVATION OF RIGHTS UNDER COLOR OF LAW (18 U.S. CODE § 242)

On January 27, 2020, the United States Secretary of Health and Human Services declared that COVID-19, a respiratory illness spread by close contact through respiratory droplets, presents a public health emergency, and the World Health Organization characterized the COVID-19 outbreak as a pandemic on March 11, 2020.

Pursuant to the Department of Public Health Act, 20 ILCS 2305, the Department of Public Health Powers and Duties Law, 20 ILCS 2310, and the Communicable Disease Code, 77 III. Admin. Code 690, the Department of Public Health adopted emergency regulations, 77 III. Admin. Code 690.50, on August 7, 2020, and clearly designates a medical exemption to any requirement to wear face covering as follows:

Any business, service, facility or organization open to the public or employees shall require employees, customers, and other individuals on the premises who are over age two <u>and able to medically tolerate a face covering</u> to cover their nose and mouth with a face covering when on premises and unable to maintain at least a six-foot social distance. (IDPH Rule §690.50(c)(2))

Myself and my children have a medical condition where I cannot wear a face covering or other PPE that covers my mouth and nose. This condition is recognized under the Americans With Disabilities

Act of 1990. As a part of a protected class under this act, I have no legal obligation to disclose any details of my medical condition.

Under Title 42, chapter 126 USC, known as the Americans With Disabilities Act of 1990 (ADA), discrimination and segregation on the basis of a protected medical condition is strictly prohibited inder federal law.

Laws and Regulations Applicable to Law Enforcement and Government Agents

- No qualified individual with a disability shall, by reason of such disability, be excluded from participation in or be denied the benefits of services, programs, or activities of a public entity, or be subjected to discrimination by any such entity. (28 CFR §35.130)
- Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States [...] shall be fined under this title or imprisoned not more than one year, or both (18 USC §242)

Laws and Regulations Applicable to All Places of Public Accommodation

- No individual shall be discriminated against on the basis of disability in the full and equal enjoyment of the goods, services, facilities, privileges, advantages, or accommodations of any place of public accommodation by any private entity who owns, leases (or leases to), or operates a place of public accommodation. (28 CFR §36.201)
- **Denial of participation**. A public accommodation shall not subject an individual or class of individuals on the basis of a disability or disabilities of such individual or class, directly, or through contractual, licensing, or other arrangements, to a denial of the opportunity of the individual or class to participate in or benefit from the goods, services, facilities, privileges, advantages, or accommodations of a place of public accommodation. (28 CFR §36.202(a))
- Participation in unequal benefit. A public accommodation shall not afford an individual or class of individuals, on the basis of a disability or disabilities of such individual or class, directly, or through contractual, licensing, or other arrangements, with the opportunity to participate in or benefit from a good, service, facility, privilege, advantage, or accommodation that is not equal to that afforded to other individuals. (28 CFR §36.202(b))
- Separate benefit. A public accommodation shall not provide an individual or class of individuals, on the basis of a disability or disabilities of such individual or class, directly, or through contractual, licensing, or other arrangements with a good, service, facility, privilege, advantage, or accommodation that is different or separate from that provided to other individuals, unless such action is necessary to provide the individual or class of individuals with a good, service, facility, privilege, advantage, or accommodation, or other opportunity that is as effective as that provided to others. (28 CFR §36.202(c))
- In determining whether an individual poses a direct threat to the health or safety of others, a public
 accommodation must make an individualized assessment, based on reasonable judgment that relies on
 current medical knowledge or on the best available objective evidence, to ascertain: The nature,
 duration, and severity of the risk; the probability that the potential injury will actually occur; and whether
 reasonable modifications of policies, practices, or procedures or the provision of auxiliary aids or
 services will mitigate the risk. (28 CFR §36.208(b))
- A public accommodation may impose legitimate safety requirements that are necessary for safe operation. <u>Safety requirements must be based on actual risks</u> and not on mere speculation, stereotypes, or generalizations about individuals with disabilities. (28 CFR § 36.301 (b))

Given IDPH Rule §690.50(c)(2) provides for a medical exemption, I am exibiting no symptoms of COVID-19, and I have no reason to believe that I am infected or transmitting COVID-19, the real risk I pose to the health or safety is negligable and is significantly less than the actual harm caused to me by wearing a face covering and facing real discrimination.

YOU ARE HEREBY NOTIFIED, discrimination and segregation on the basis of a protected medical condition is strictly prohibited and you are in violation of federal law and regulation.

My name is Alyse. I've been a resident of St. Charles for 10 years. My family immigrated here from Italy 100 years ago and took root in Chicago.. We moved to the suburbs when I was a kid, and have always loved the family feel of St. Charles. I'm hoping this experience helps you to see how wrongly your staff is treating it's residents.

On a normal day at the library with my 5 children, I was approached by not one, not two, but three staff members, including your security guard. Did I damage books? No. Did I get belligerent with another patron? No. My crime, and I say that loosely, was my 7 year old twins, with documented medical conditions, had faceshields on. Even after offering to show their doctors note, I was told to leave if they could not wear a mask. I should also add that myself and my 5 year old had masks on. THIS Is discrimination. You cannot tell me that I have to use your drive up service. That is not a reasonable accommodation. What you're doing is disgusting and illegal. Not only did I leave in tears but I shared my experience. And would you believe there's a whole community of us who have experienced the same harassment. Imagine that. I would like to receive a link to attend the meeting and please take note of my public comment provided below.

I'm horrified that there would be threats of physical violence made to library staff. I'm also horrified that the library would ban tax payers from using their public facilities for not wearing a mask. Unfortunately, the law does not afford you the ability to make such a maneuver.

First there was Panic. Then there was Power. Now the Wheels are Coming Off. It's Time to Build.



Dear St Charles Illinois Public Library Board of Directors,

We learned of threats to our library on the news yesterday. The news reported that these threats were via phone calls and email.

As patrons of decades, we were greatly disheartened. We have had frequent interactions with numerous library staff over the past 22 years, or more. Every staff member has been warm and welcoming and gone the extra mile to help us with our many requests. Our family utilizes the library for almost every available resource, including museum passes and near-daily book requests. To say that the library has been hospitable and accommodating, educational and supportive would be a gross understatement.

Our family's particular use has been, perhaps, extraordinary, considering the volume of materials that we request, including purchase requests and research and many reference questions. We have always been impressed and awed at the variety of services. The staff bends over backwards to be of the greatest service possible at all times.

onsidering the stress of coronavirus restrictions and the massive undertaking of the recent remodeling and move of materials back and forth to our enhanced library campus, one might expect some compromise in the delivery of services. This has not been our experience at all. The speed of turnaround and the grace with which these offerings are rendered has remained intact despite unprecedented challenges.

It is heartbreaking and devastating to contemplate that our beloved and cherished library staff has received pushback of any kind, much less any form of threat via email or voicemail. What the library staff deserves is thanks and credit in their brave efforts to serve, and to keep our community safe in adhering to our Governor's mandate. (One might wonder how many national deaths, and even local deaths and severe illness, it would take to impress upon some citizens the severity of this highly transmittable illness). Simple masks are not a political statement, and at this time are really not even a choice in certain public venues. They are simply a life-saving, easily accessible, inexpensive, readily available and necessary, temporary, preventative measure- right up there with hand washing and social distancing of other types. The efficacy of mask wearing in the prevention of the spread of coronavirus has been well demonstrated scientifically, and is implemented by many institutions in order to save lives.

While we as Americans are free to protest and together and to voice our opinions, it must never be in threats of any type. Our public servants are already spread thin by many other threats, and to add to this burden is unreasonable and unfair. Coming into a public facility without a mask, knowing full well what the current mandate is, seems like a temper tantrum. It does not represent choice to our children, but shows disrespect and lack of compliance to reasonable and even legal mandates, even if temporary. There are rules in order to protect our freedoms everywhere and it is particularly important to set an example since children need to be compliant a order to stay safe at school and in other settings where people gather.

It is our hope that during this evening's meeting that the board will remain firm in enforcing safety measures until the Governor has ruled differently. We know that you will reassess at that time, and we hope that you will keep necessary protective measures in place so that the majority of compliant patrons can continue to enjoy the 'ibrary. We know that you have extensive services online for people in their homes as well. It is always better to fr in favor of safety in these crucial times. This has been unprecedented and has been difficult upon businesses and institutions to understand what to do and to flex with new information.

But at no point should any institution be bullied into acquiescing and accommodating those who would be threatening. It is not the library's intolerance, but the intolerance of a few who would jeopardize the health and safety of the majority in order to assert what they think are their rights under the constitution. It causes trouble and discord and disharmony, and destroys the peace and safety of the majority of patrons who are happy to simply throw on a mask for a few minutes to help keep the vulnerable safe. We understand that this is complicated and complex, but it really does seem like a no-brainer. We hope that our library will not yield to these pressures, but will stand firm and that the community and any safety resources that exist will rally behind you until this health crisis passes.

Subject: About the closing of the library due to threats...

My wife and I are recent arrivals in St. Charles (4 yrs).

We LOVE the St. Charles Public Library and commend the staff and board on managing through the pandemic as well as the wonderful renovation of the physical library facility. Bravo!

I saw the news item about closing the library and want to make three observations:

1. The library is on the edge of a significant public relations crisis.

This situation can potentially create real damage to your image and level of support in the community. The statewide mask mandate has put you in the role of maintaining compliance. The normally friendly and helpful staff must now also function as the "library police" on behalf of the Illinois executive order. The news item that indicates you are working with the St. Charles police, while understandable, only underscores the sense that the solution being sought is how to restrict the "bad actors" sending threatening emails to the exclusion of addressing why in the world anybody would threaten a library in the first place.

2. The citizens of St. Charles are not your enemies.

Hunkering down in some sort of defensive mode would be, in my opinion, a mistake. The library is a community asset, not a fortress. My observation is that the citizens of St. Charles have many reasons for Juestioning the mask mandate currently in place, including: a) the mask mandate in Illinois has not provided any demonstrably better outcomes in terms of covid morbidity or positivity rates than in states without the mandate, b) the mask mandate is largely ignored in many public and private establishments in St. Charles and throughout Illinois...with no consequences to the patrons of those public and private establishments (the exception being Chicago and Cook County), and c) this leaves many to conclude the wearing of a mask as largely irrelevant -- sort of like a mandate for all to wear a purple hat on Thursdays or be denied admission to the library. This seems a poor choice as *the* defining issue on which the library Board is willing to sacrifice its good standing with the patrons of St. Charles.

3. The opportunity to partner with the community for a better future

I believe you have an opportunity to, yes, take prudent safety measures on behalf of staff and patrons with appropriate consultation involving law enforcement, but also to make some sort of public statement that you are in dialogue with public health officials and/or the office of the governor to advocate for an end to or modification of the mask mandate. I notice that the St. Charles Gov't Operations Committee decided it would not require vaccination verification for business patrons in St. Charles and the mayor of Naperville has called for an end to the mask mandate. Neither of these actions actually ended the Illinois mask mandate, but they do give a signal to the public that city officials are aware of the situation and not punitively enforcing a policy that many have concluded, in perspective and practice, is no longer worth enforcing.

A public statement and a "masking optional" or "no masks required in study rooms or meeting rooms of the library" might be an option.

Jou all know the dynamics of library administration better than I, but this is a critical moment when what you decide -- and how it is communicated to the staff and the public -- is especially important. The future relationship between the library and its community can be either strengthened or damaged by your actions now.

This is appalling that your librarians lack the compassion to handle these situations accurately. While no kid should be forced to wear a mask which most states have realized, this family found an alternative to try an appease your fears and rules yet you lack the basic critical thinking skills to realize they pose no real harm to you. It is amazing that your library is still strictly enforcing this mask mandate after 2 yrs. There is a multitude of evidence that masks are ineffective and do not curb the spread of an airborne respiratory virus.

On top of that, the world health organization (WHO) has recommended against masking kids under 6 and only encouraging mask use in 6-10yr olds. The CDC guidelines have not been adopted by most states. Most states leave it up to local control and in those states, most are mask optional especially for kids.

Alabama, Alaska, Arkansas, Colorado, Florida, Iowa, Kansas, Kentucky, Louisiana, Maine, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, North Dakota, Ohio, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, West Virginia, Wisconsin, and Wyoming all do NOT require masks statewide. That is 29 states. Then there is Georgia which is mask free except for major cities like Atlanta, but that in Atlanta it is only kids over 10yrs old.

Ievada is statewide,, but for people over age 9.

Not only that, but most states or cities requiring a face covering following these guidelines have a clauses like these:(Like this one in Maryland-)

Cloth face coverings should not be placed on young children under age 2 (and under the Executive Order, are not required under the age of 5), anyone who has trouble breathing, or is unconscious, incapacitated or otherwise unable to remove the mask without assistance. Customers with disabilities who cannot wear a cloth face mask, plastic full-face shield, or other suitable face covering, shall be provided reasonable accommodations in accordance with the Americans with Disabilities Act (ADA Title II and III).

Customers cannot be asked invasive questions about a disability or asked to provide medical documentation or other proof of a disability. Employees or staff that cannot wear a face covering due to a disability may request reasonable accommodations in accordance with the employer's disability policies and procedures (ADA Title I). An employer's policies and procedures may require documentation to grant reasonable accommodations.

Even in our own state, many places recognize limitations that allow for face shields, or nothing and realize they have no right to ask or question a person's health status.

Dear St. Charles Library Board of Trustees,

I am writing to condemn the failure of law enforcement, as well as the Kane County State's Attorney, to charge Shannon Adcock, President of Awake Illinois, and Chrissi Bretz, of Freedom Illinois, for their "maskless" ambush on the St. Charles Public Library. As you are aware, the public library was forced to close for their own "health and safety" due to the inaction by their own local law enforcement agency.

The library is a public place and this demonstration was not protected by the First Amendment. The First Amendment has always been subject to time, place and manner restrictions. A quiet library is not the appropriate place or time to bring a plethora of maskless children, while their disruptive parents film loud ideos to advance a maskless political agenda. This display endangered every patron and staff member's health during COVID-19. It should not need to be reiterated that a mask does not necessarily protect the wearer – it protects those around them.

The library acted within their rights by calling law enforcement for help. These agitators could have easily put masks on and they would have been allowed full access to the services of the library. They continued to proudly refuse, while law enforcement failed to make any arrests. Whether or not it would have been easy to make arrests with children present is not relevant. This is why social service agencies exist. The adult agitators could have been arrested and their family members could have been called by social services to pick up the children. If the presence of children shields adults from arrest, imagine how many unsafe situations children can expect to be placed in the future. The precedent being set is dangerous.

The standard for disorderly conduct is whether these agitators acted unreasonably so as to "alarm" and "disturb" other persons, causing a breach of the peace (See Link to Statute at Bottom). This was their intent. They entered in a large group, refused to wear masks and began loudly making video broadcasts of their unreasonable demands. While they placed others at risk for contracting COVID, they bragged about their conduct on social media platforms, including Instagram, Facebook and Twitter. By the very nature of the library having to call the police, it is clear the library staff was alarmed and disturbed by this ambush. If staff had felt safe, they fould have felt no need to involve law enforcement.

Based on social media posts by Awake Illinois, an organization that claims 501(c)(4) tax-exempt status, the intimidation tactics on the library continued after these extremists left the building. They continued to send their followers to the library without masks following their ambush, while posting the library's warning letters and Awake's Facebook page as a badge of honor. The comments under these posts indicate that followers continued to call the library and harass them for their mask policy.

In the simplest of terms – St. Charles Library was targeted by two extremist groups and they received no assistance by law enforcement or the State's Attorney. Just like many victims of these organized extremist groups, they were left to fend for themselves against armies of agitators that do not always appear to exercise the best judgment. If these groups had exercised any judgment in this scenario, they could have protested on the sidewalk outside the library. If they had truly wanted to use the library's services, they could have worn a mask and had no issue with access to the library.

My child and I go to the library on a regular basis and check out 30-40 books at a time. Without our public library, I would be forced to spend roughly \$5-\$20 per day on books for my child. Ms. Bretz states in her "Freedom Illinois" video that she largely buys her own books at the 10:20 minute marker. Most parents cannot afford to spend twenty dollars a day on a book. The shutdown of the library impacts poor and middle-class families, while the wealthy continue to enjoy books through purchase. Without the library being open, there will be an inequity that persists in our society where wealthy children are given greater access to educational tools, while less fortune families cannot provide their children with the same academic resources.

I do not care if the St. Charles Mayor, police or State's Attorney think that masks are trivial. They have all taken oaths to uphold the law. The law dictates that these extremists should have been arrested for Disorderly Conduct and Trespassing. If they cannot honor their oath and enforce the law, St. Charles has a greater problem than just their library being closed – they have a community where some individuals and groups are held to be above the law, depending on the enforcer's personal belief system. This is not sustainable in any free society.

If arrests are not made in this matter, it is my request that donors are allowed to give to the library so that they can afford to pay for private security to allow the library to have a safe reopening. As a person who actually uses the library, it is by far cheaper to donate for private security costs than it would be to purchase all of the books that I checkout in a month. Please advise on how to appropriately make such a donation if law enforcement cannot keep them safe.

Dear St. Charles Library Board of Trustees,

I am writing to strongly condemn the failure of law enforcement and the County State's Attorney to arrest and press charges against Shannon Adcock, President of Awake Illinois, and Chrissi Bretz, of Freedom Illinois, for their "maskless" ambush on the St. Charles Public Library.

Libraries are public places, and protecting the common good matters in them. This baseless and unwarranted demonstration is not an exercise of anyone's First Amendment rights, but was instead an act of terror designed to endanger the health and lives of others -- including the endagerment of the disruptive parents' own children, as well as every patron and staff member's health during COVID-19. It should not need to be reiterated that a mask does not necessarily protect the wearer – it protects those around them.


Good afternoon,


Remarks for Emergency Meeting 1/22/2022

My name is Wanda Rundle and I have watched this entire situation unfold on social media since Sunday, January 16, 2021. On that date there was a social media post made claiming that the police were called on a 10 year old for not masking at the St Charles library. This was amplified by an anti mask activist from Wheaton named Jessica Hockett who uses the Twitter handle for the property of Geneva who runs Freedom Illinois and Shannon Adcock of Naperville who runs Awake Illinois hatched a plan to have a maskless protest at our library on the morning of the 18th. Note that not one of these people are from St Charles. On the 18th I had a phone call with Kelly at the library after seeing Awake's livestream and expressed my concern for this occurring on the premises as well as my support for the staff as they do not deserve to be the subject of the political ire of these groups. The January 16th incident never occurred and so this entire protest was created based on a lie from some bored mom trying to gain social media clout in her Facebook group.

I reached out to the Mayor regarding what I considered to be inadequate support from law enforcement and from the city regarding this behavior. She said that these were just moms and their children enjoying the library services and that the police acted appropriately. I vehemently disagree. And there is evidence to support that because if the incident was "handled" correctly the first time then the behavior would not have escalated every after January 18th leading to our library having to close its doors to the public for in person services. They got away with it according to their videos, yet they continue to harass the library. What is their end game? It isn't adding up.

The recurring argument from these groups is that masking is a mandate and not a law and therefore they can do whatever they please. However, that is not the example we should be setting for our children, nor is that the society we should strive to live it. There are a number of rules or guidelines that we follow that are not laws that can be enforced to the extent that if they are not followed you then are breaking the law by not honoring the request of the premises. This is the very reason trespassing and disorderly conduct laws exist. In this case there were clear violations both in their refusal to mask up or leave and in their video recording. Legal action would be appropriate especially since they are still on social media antagonizing the community about their exploits.

St Charles Library is not responsible for the mask mandate and taking out their aggression on the library is misplaced and only harms the community. It doesn't matter what anyone's personal feelings are on masking are here, because again the librarians and library board didn't set the guidelines. Take it up with Springfield, take it up with Pritzker. However, we as members of a society, have a responsibility to conduct ourselves with respect for each other and our community. I think it is telling that Shannon and Chrissi didn't cause trouble in their own communities. They didn't take resources away from their towns. They did it in a place where they don't have skin in the game. And now they know St Charles police will look the other way the next time they want to stir the pot. They have been bragging about it on social media all week. I hope the board will look to take legal action against Shannon, Chrissi, and their organizations. But I stand with the library staff and their decision to honor the policies in place and posted on the door because they were in a tough position and the library patrons ho were there and masked didn't deserve to be part of that spectacle.

Board meeting comments

Hi, you do not need to read this outloud at the meeting if you feel it is too lengthy, but I do hope all of the board members will take the time to read my thoughts and comments. Thank you!

Good evening, and thank you for taking the time to listen to public comments. I am viewing this situation through many lenses - I am a parent of four children, ages 7-13, I am a taxpayer in the city of St Charles, I am an educator in our community, and I am an American who embraces the fact that our country was founded on the principle of freedom. Every day in our schools, we recite the pledge of allegiance. You may have even recited it at the start of the meeting. Please keep in mind, the last 7 words of this pledge of allegiance are, "indivisible, with liberty and justice for all." It doesn't say "indivisible, with liberty and justice for some."

When an organization attempts to restrict access to a certain group or individual, based on an overreaching and unreasonable government mandate, civil disobedience happens. With Black History Month looming on the horizon, I am guessing you are getting ready to stock the displays with books about Rosa Parks who as a black woman in the 1950s was "required" to give up her seat to a white man but refused to do so in protest of the unjust segregation laws. In much the same way, others throughout history have performed similar heroic acts. In much the same way, a group of individuals chose to enter our library without masks in the hopes of receiving equal treatment for themselves and their children.

Now for a question. Has anyone on the library board been out shopping in our community lately? I'm guessing that's a yes from all, but if not I'll tell you what I have observed. Most people wear masks but a handful do not. Those few who do not wear masks, go about their business just like all the other patrons do. At Meijer and Target, the store employees smile and greet their fellow unmasked humans politely, the same way they greet the masked patrons. They are not calling the police on them or becoming confrontational. They work to maintain a welcome and friendly environment for all, not just for some.

Sadly, throughout covid, my family has not been made to feel welcome at the St Charles library. When the books were being housed at Haines, in order to gain access, we were screened for fevers and asked to sanitize our hands. Even after doing these things to ensure safety, library employees followed my kids around the youth section asking them not to touch the books unless they were planning to check them out. As any person who has visited a library knows, part of the joy of choosing a book is sliding it out of its place on the shelf, looking at the cover, and flipping through the pages before making a decision. It was so awkward visiting this library and being followed around that we started going to the Geneva library instead. They did not follow my kids around telling them not to interact with the books.

When the new library opened, we decided to give it another try. Fortunately we don't have to have our temperatures taken and we are now allowed to touch even the books we might not decide to check out, but the mask enforcement has gotten out of control. I went into the library last week with my 11 year old daughter. She and I were out visiting relatives and on the way back made a spur of the moment decision to run in and grab a book we had waiting in the holds area. I had a mask in the car but she didn't. In the past we have asked at the esk for a mask if any of us were without, but because I knew it would be a quick in and out visit, I didn't think it was necessary to ask for one. However from the time it took us to walk in the front door to get to the holds section (less than one minute) we were stopped by 3 people asking her to put on a mask. 3 people approached us

in less than one minute! Wow. It felt a little bit like an ambush. One male employee even followed me to the self check and strongly encouraged me to use the drive up window in the future. I think, after this experience, I would rather use the Geneva library in the future.

Jople in our community want to feel welcomed and respected. We do not stand for discrimination even when it comes in the form of an unconstitutional government mandate. I ask that you encourage your employees to treat people with respect equally and with kindness equally. In the hopes of remaining an indivisible nation, we all have a role to play. Please do not let the mask issue divide our community further, please do not encourage discrimination, and please do not let the mask mandate and covid fear determine how your organization treats its visitors.

As the department manager, I am writing on behalf of the Youth Services Department. The youth services department fosters imagination, growth, and empathy. The staff are creative, caring, and passionately dedicated to providing service to children and families. The collective work of the youth services team reaches so many families and creates lifelong learning opportunities that change people's lives for the better. Working in youth services, we are acutely aware of the needs of a wide variety of users. In the course of a day, we may serve an unvaccinated baby, a boosted middle schooler, a pregnant mother vaccination status unknown, or an immunocompromised unvaccinated grandparent. We also serve families feeling the greater effects of unemployment, food insufficiency, and homelessness. We owe them all a safe environment. The youth service department exists as a gateway to learning and literacy. The staff provides services inside the newly reimagined and renovated library, online, and in the community through outreach programs and community partnerships.

Our mission is <u>not</u> about refusing service to the community, but rather giving our best to families and children. The recent events are more than unfortunate. Staff, who were simply trying to do their jobs in upholding the library's policy, were verbally harassed, yelled at, had their personal space invaded, and on top of that, recorded in way that akes them seem so much less than what they truly are. Staff feel threatened by social media posts and their mental wealth has suffered. They feel the effects of the ongoing intimidation and it has caused them to fear coming in to work. Good evening, my name is Carla Williams, and I am the Staff Representative for AFSCME Council 31, the union representing St. Charles Public Library staff. We believe staff deserve to work in a safe environment, free from harassment. We call upon the library board and library management to implement proper safety and security protocols, including an effective procedure for handling protestors who refuse to wear masks without risking the health or safety of library staff and patrons.

Prior to Tuesday's protest, staff members and our union contacted Library management about the threatened action. Our concerns were not taken seriously. On Tuesday, January 18th over thirty (30) protestors (adults and children) entered the library and refused to wear a mask. The protestors invaded staff and patrons' personal space. After the St. Charles police arrived and the protestors refused to comply and leave, both the police and Library management effectively abandoned impacted staff to deal with the protestors with little to no support for over an hour. Patrons were not warned protestors were in the building. At no point during the protest was the building temporarily closed. In fact, an email was sent to staff claiming that the situation was defused while there were still protestors in the building. As they were leaving, the protestors threatened that they would be back. As promised, several of the protestors again entered the library refusing to wear a mask two days later. Additionally, there were threatening posts and threatening communications directed at library staff.

We appreciate that the Library ultimately made the decision to temporarily close the library for walk-in services, but staff still feel unsafe and a number of patrons have expressed concerns about safety.

We are calling on the Library Board to take the following actions:

- Institute safety procedures such as temporarily closing the library in response to future demonstrations/protests; mandatory communications to all staff, regardless of exemption status.
- No staff member should be required to interact with protestors without a member of Library management present.
- Enforce the Library's Photography, Security Camera and Other Recording Devices policy.
- Assign security to the front door during open hours and survey departments with public service desks on what is
 a safe staffing level.
- Ban all members of the public who participated in the January 18th and 20th protests and who sent threatening communications to the library.
- Provide COVID testing for all staff on work time who worked on January 18th and 20th during the hours that the
 protestors were in the building.
- Purchase NIOSH approved KN95 and N95 masks for staff from a manufacturer approved by the CDC.
- Provide COVID Sick Time for all staff.

Comment re: Mask Policy Incident

I would like to comment on the situation that occurred at the library regarding anti-mask patrons, however, I am not comfortable making my name, address and phone number public for fear of retaliation by anti-mask zealots. I live in St. Charles and given the response by the St. Charles Police dept, I have no confidence that they would protect me in the case of retaliation.

There are two issues here. 1. People defying the library's mask policy, and 2. What it means to civil discourse when the police take sides on an issue. This should be a concern for everyone living in our community.

The STC Police mission statement is "to protect and serve our community with respect and a commitment to excellence." The library staff felt threatened enough to call the police and the STC police did nothing to sperse the protestors occupying the library. Is this an example of their mission statement in action? Or is it simply inaction? Did the police use de-escalation techniques to diffuse the situation? Viral videos and social media claim that the police told protestors that they "agreed with" and let them occupy the library unmasked. Did this help build trust in fair and impartial justice in our community? Did this serve the library staff who called the police because they felt threatened?

I hesitate to speak up for fear of retaliation or harassment by partisan ideologues. Also if I was targeted with harassment, I now know that the STC Police have set precedent that they will not prevent others from harassing me if the police agree with the harassers ideology. I fear the police will not serve and protect me because they feel that they can pick and choose which laws, or guidelines they agree with and want to enforce. The City of St Charles police feel that they can discriminate their law enforcement. Do the police only enforce the laws for people with whom they agree? What if the officer is Catholic and I am Lutheran, or atheist? What if I am wearing a Blue Lives Matter shirt? Or a Black Lives Matter shirt? What if I voted for a different politician than they did?

he City of St Charles municipal buildings, offices and public meetings require masks to be worn by all individuals. The St. Charles Police department has signs on their doors requiring people to wear masks in the

building. Yet they did not enforce this policy when the library called for assistance. What would the city do if an anti-mask group refused to comply with this request in the city municipal building or police station? If I fused to comply, would I be arrested? If so, under what charges would I be arrested? Why do those charges not apply to the protestors who refused to comply with the library's mask requirements?

There are enforceable laws that police can and do use to handle hostile groups if they are intimidating others, or being disruptive: Loitering (city code 09.21.010), disorderly conduct (City Code 9.20.010), disturbing the peace, and trespassing (city code 9.44.040) as well as City code 8.12.030 (spreading contagion). City code 8.04.080 (Acts endangering public health) states that it is unlawful to commit or do any act which endangers the public health. Refusing to wear a mask during the COVID pandemic endangers public health. This is a fact, not an opinion.

The library has signage on the doors informing patrons of the mask policy. If a customer doesn't wear a mask but still enters the business after seeing the signage, by most people's definition that shows <u>intent</u> -- you read a sign and you didn't obey the sign. In most states, that is criminal trespass.

Their intent was not just to use library services and exercise their choice not to wear a mask. There are several ptions available for patrons to use the library without violating library masking requests, by using the drive up window and online services. This was a large organized group who intentionally refused to comply and insisted on occupying the library and defy the mask requirements to make a statement. Their intent was intimidation. I am not inferring this intent or reading minds; Social media posts confirm that this was their intent.

Disturbing the peace and disorderly conduct do not have to be loud, physically violent activities in order for them to be harassment. The anti-maskers may be fairly quiet yet still threaten others by their intimidating behavior. How do we know that they were intimidating? Because the library staff felt compelled to call the police. The burden of proof should not fall on the victims. That's like saying that unwanted sexual comments are not sexual harassment if the person saying them says they didn't mean them to be offensive. If the recipient finds it offensive or unwanted that is enough proof. If the library staff felt threatened enough to call the police that is proof enough.

Do the anti-maskers get to decide if they believe COVID and wearing a mask are real or not? Sure they do. But to they also have the privilege to decide which laws they believe in and will obey? Do they have the privilege

to endanger other people with your decisions? Do I have that privilege too? What about the library employees, what rights do they have?

Because of the actions of a handful of selfish, privileged people, the library is now closed to all in-person activities. We cannot have nice things in society if people cannot be civil and think about others. And because the St Charles Police choose to take sides when enforcing the peace, we cannot count on them to serve and protect us.

Dear Board,

I timed myself reading my comment and comes out to under 2 minutes. Please read my full public comment.

PUBLIC COMMENT STARTS:

As a community member I agree with our Library Board that all Patrons need to follow all laws and local mandates when getting services and enjoying public spaces at St Charles Public Library. Your current requirement is not found online under library polices but under an August news release titled "Library Mask Requirements". That news release states the "[St Charles Public Library] is following the recommended guidelines." The local guideline cited is: "Kane County Health Department Reminds Businesses and Residents of Mask Mandate." That reminder includes a copy "FAO on Face Covering and Vaccine Requirements" which is an Illinois Department Public Health 8 page Locument which covers all 4 exemptions in detail. The executive order and FAQ were released both on Sept 3 2021

The 4 groups that are exempt are: individuals under the age of 2, have a disability preventing safe mask wearing, medical intolerant to face covering, and free exercise of religion.

St Charles Public Library offers alternative services in the form of curbside pick up. Patrons might consider utilizing alternative services, however per "FAQ on Face Covering and Vaccine Requirements" document, alternative services are recommendations not requirements for individuals with exemptions. "Individuals and businesses might consider the following alternatives" and then states four suggested alternatives. Preceding that sentence is "Persons who cannot medically tolerate a face covering are exempt from the Order" The FAQ document makes no mention of limits or mention of safety or undue hardships created by individuals with exemption. Please add all 4 exemptions to St Charles Public Library "Library Mask Requirements."

During my next visit to St Charles Public Library to utilize our public space and access materials, I will exercise my sincerely held religious belief object to the face covering requirement, I will be exempt per FAQ on Face Covering and Vaccine

Requirements document, and I do not wish to be discriminated and/or segregated based on my religion per 42 USC 2000a.
